### **INTEL PLANS INVESTMENTS IN EUROPE**

Intel has announced plans for an initial investment of more than 33 billion euros to build a leading-edge semiconductor fab mega-site in Germany, to establish a new research and development (R&D) and design hub in France, and to expand capacities in R&D, manufacturing, foundry services and back-end production in Ireland, Italy, Poland, and Spain.

- Intel will invest nearly \$90 billion in Europe's chipmaking industry -CNN
- Intel will spend \$19 billion building German factories, add sites in France and Italy – The Oregonian

### WILL INTEL STILL MATCH DONATIONS TO HELP UKRAINE?



**YES!!!** While the Intel Foundation's Ukraine Humanitarian Relief campaign has ended, retiree donations to eligible causes continue to be matched under the Foundation's Donation Matching program <u>guidelines</u>.

The Intel Foundation launches unique campaigns to help with natural disasters and crisis relief efforts. These campaigns select eligible causes with total donations subject to a matching cap. This IRO web <u>page</u> has more details on how these campaigns work.

The Ukraine Humanitarian relief campaign's initial matching cap was \$250,000. Due to the tremendous response, this cap was doubled twice to \$1 million, which raised a total of \$2 million dollars

before the scheduled end of the campaign. Intel continues to work with Benevity to identify causes that are providing Ukraine humanitarian relief. These are found on this Benevity **webpage**.
