INTEL CEO PAT GELSINGER VENTS ABOUT OHIO CHIP PLANT DELAY: <u>'IT'S SUCH A PIVOTAL</u> MOMENT. PLEASE DON'T DITHER IN CONGRESS.'

Intel recently warned publicly that it could delay the Ohio plan and cited the failure in Congress to pass the CHIPS Act, which includes important chip industry subsidies of up to \$52 billion (\$40 billion for manufacturing and \$12 billion for R&D), a version of which was already passed by the Senate over a year ago.
