WHAT YOU NEED TO KNOW ABOUT OPTING OUT OF SERMA

To be eligible for Federal subsidies that lower your healthcare premiums through your eligible exchange, you must choose the SERMA "Opt Out" option (subsidies are determined based on your total income claimed when you file your taxes with the IRS) [Click for more "opt out" information](#)



VACCINES AND EXPRESS SCRIPTS

It was recently discovered that vaccines that should be covered under the pharmacy benefit managed by Express Scripts have been rejected as not covered. This is incorrect as these items are covered under the Intel Prescription Drug Program. This issue is now corrected, and you should be able to purchase the vaccines under your plan at no cost to you.



If you had a claim rejected, you may have obtained these vaccines by an alternative means, like through your doctor's office since they are also covered under the medical plan. If you paid for one of these vaccines at a pharmacy, you can submit your receipt for reimbursement online at [express-scripts.com](https://www.express-scripts.com). \$10B IN CUTS: INTEL CEO PAT GELSINGER BEMOANS 'DIFFICULT DECISIONS' IMPACTING 'LOYAL INTEL FAMILY'

Intel CEO Pat Gelsinger Thursday laid out a "right sizing" plan to cut \$3 billion in 2023 and as much as \$10 billion in costs by 2025 in moves that he said will impact headcount.

"Inclusive in our efforts will be steps to optimize our headcount," acknowledged Gelsinger in a conference call with Wall Street analysts. "[These are difficult decisions affecting our loyal Intel family.](#)" Intel has 121,100 employees.
