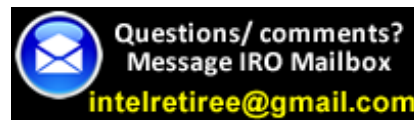

GATHER YOUR SERMA REIMBURSEMENT RECEIPTS



The SERMA plan year runs from January 1 through December 31 of each year. You may submit for premiums incurred during these dates as long as you file your claim after your coverage began and before the **run-out period ends, which is May 31** of the following year. The farthest back you can submit would be January 1 of the previous year. MEDICARE ANNUAL ENROLLMENT DATES

[When does Medicare coverage start?](#) Generally when you turn 65. This is called your Initial Enrollment Period. It lasts for seven months, starting three months before you turn 65, and ending three months after the month you turn 65.

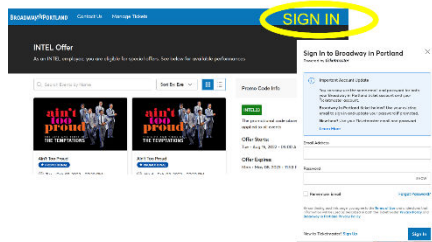

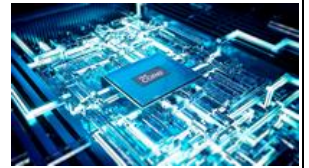

If you have not received your W-2 by the middle of February, call the Get HR Help 800 number (1-800-238-0486) to request a copy. If you have received your W-2 and have questions, you can also request a W-2 Breakdown Letter which details what was included in each box on your W-2
